These prices are effective as of December 1, 2016, and are subject to change without notice.

The goods and services shown below are those we provide to our customers. You may choose only the items that you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statements we provide describing the funeral goods and services you selected. The survivor of the deceased who is handling the funeral arrangements, or the responsible party, is entitled to receive, prior to the drafting of any contract, a copy of any agreement that has been signed and paid for, in full or in part, by or on behalf of the deceased, and that is in the possession of the funeral establishment.

#### A. PROFESSIONAL SERVICES:

**BASIC CHARGES AND OVERHEAD** **\$1595.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee includes the following:

- Personnel available 24 hours a day, 365 days a year to respond to the initial call.
- The Arrangement Conference.
- Coordinating service plans with the cemetery, crematory and/or other parties involved in the final disposition of the deceased.
- Assisting in obtaining necessary authorization and permits
- Covers overhead, such as facility maintenance, equipment and inventory costs, insurance, administration expenses, and governmental compliance.

FROM MORTUARY TO/FROM AIRPORT OR CREMATORY\*\* \$298.00  
 Transfer of the deceased from the mortuary to/from the airport or the crematory.

FROM ANOTHER MORTUARY\*\* \$198.00  
 This charge includes minimum services of staff. This charge does not include visitation or ceremonies.

TO ANOTHER MORTUARY\*\* \$198.00  
 This charge includes minimum services of staff, necessary authorizations, use of preparation room and local transportation (excluding shipping charges and shipping container). This charge does not include use of facilities and staff for visitation or ceremonies.

PREPARATION OF REMAINS FOR VIEWING:

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to select an arrangement that does not require you to pay for it, i.e. direct burial, cremation.
